Student dormitory Trsat is located in the eastern part of the Rijeka called Trsat which is well connected with other quarters of Rijeka. Student dormitory Trsat is located close (walking distance) to the following faculties:

- Academy of Applied Arts
- Faculty of Humanities and Social Studies
- Faculty of Civil Engineering
- Faculty of Teacher Education
- Department of Biotechnology
- Department of Physics
- Department of Informatics
- Department of Mathematics

To reach other faculties of University of Rijeka it is necessary to use public transport or car. The best option is the bus. Below you can find the bus lines driving from Student dormitory Trsat to close to the other faculties:

- Faculty of Economics: buses 2, 7, 7A, 8
- Faculty of Tourism and Hospitality Management: you have to reach the centre of Rijeka by buses 2, 8, 8A, 7 or 7A and then take the bus 32
- Faculty of Health Care Studies: buses 7, 7A
- Faculty of Medicine: buses 7, 7A
- Faculty of Dental medicine: buses 2, 7, 7A
- Faculty of Maritime Studies: buses 2, 7, 7A, 8
- Faculty of Law: buses 7, 7A
- Faculty of Engineering: buses 7, 7A
- Polytechnic of Rijeka: buses 7, 7A

3. Student dormitory Trsat


Student Dormitory Trsat comprises three pavilions that are designed in a functional, organizational, architectural, technical, economic and spatial sense to provide quality living and studying conditions for its residents.

Student dormitory Trsat first opened in 2016 as a result of a project by the European Union and University of Rijeka.

Student dormitory Trsat consists of three pavilions: pavilion 1 (ground floor + 6 floors), pavilion 2 (ground

floor + 6 floors) and pavilion 4 (ground floor + 5 floors).

Other than accommodation facilities, there are many other facilities for students and guests in and near Student dormitory Trsat: gym and trim, infirmary, living room for students, bicycle storages, IT classroom, laundry room, restaurant Kampus, caffe bar Akvarij and Student shop.



Erasmus students can be accommodated in pavilion 1 in single rooms.

Erasmus students can be accommodated in pavilion 1 in single rooms with their own bathroom and kitchen. Kitchen is equipped with: furniture, sink, cooktop, recycle bin, refrigerator and kitchen accessories. Bathroom is equipped with: sink, shower, mirror, trash bin and toilet seat and cover. Each room disposes of the following inventory: bed, and mattress, large closet, shelfs, cork board, working desk, chair.

Every room shares the loggia with table and chairs with another single room.

When moving in, each student will receive a set of bed linen which includes: blankets, sheets, pillow, pillowcase, and mattress cover. Also, students will receive big and small towels and cleaning equipment. On request, students can get the complete list of room equipment.

4. Obligations

Student Centre's obligation is to provide accommodation service to user of accommodation in accordance with the possibilities and conditions established by Regulations of house rules and disciplinary responsibility of residents in the accommodation facilities of Student Centre Rijeka.

Erasmus student's obligation is to undertake to fully understand and to respect the Regulations of house rules and disciplinary responsibility of residents in the accommodation facilities of Student Centre Rijeka and other general acts of Centre. User of accommodation is obliged to carry out general safety measures, fire protection measures, environment protection measures and measures against natural disasters.

Regulations of house rules and disciplinary responsibility of residents in the accommodation facilities of Student Centre Rijeka are determining rights, duties and responsibilities of accommodation services users regarding cohabitation with other residents, as well as the rights and obligations of the Centre. For violation of Regulations and other decisions of the competent authorities of the Student Centre Rijeka, the resident is responsible on disciplinary and financial basis. Any violation will be considered seriously.

For violation of provisions of Regulations of house rules, student will get one of the disciplinary measures.

5. Internet access

Internet is available in each room and is free of charge. To use it, students need to get their username and password from the faculty and download the necessary installation software.

In case of connection problems, there are instructions for connecting to the Internet. Student can find it on our web page.

6. Booking

To book a room, students should contact Student centre on e – mail address: dom@scri.hr

To make a reservation, Students must send a copy of Learning Agreement / Traineeship Agreement to confirm their Erasmus status. Also, they have to confirm the date of arrival and departure.

The rooms are given to students on a "first come, first serve" basis.

7. Check - in

Students can check - in to the Student dormitory Trsat from Monday to Sunday from 6:00 AM to 10:00 PM. The exact arrival date and time of Erasmus student must be announced at least 5 days before arrival day.

Documents which students need to bring when moving in are:

- Copy of Learning Agreement / Traineeship Agreement
- Medical confirmation (needs to be confirmed by family physician in the home country)
- Identity card or passport
- Other documents on request of Student centre Rijeka's staff.

When moving in, students have to go to the reception to make check in and sign the contract.

8. Payment and prices

Monthly price for accommodation in single room......1.450,00 HRK

Important informations:

- Value Added Tax (VAT) and Sojourn tax are not included in the listed prices.
- Student Centre Rijeka (student) is exempted of paying the Value Added Tax (VAT) for accommodation of students due to Article 39., item 1, part i of the Value Added Tax Act and due to Article 58., item 1. of Value Added Tax Ordinance. This apply during academic year.
- Student is obliged to prove his status by submitting of valid document. Otherwise, student can't use accommodation service under these conditions.
- Exemption from payment of VAT does not apply during summer.
- Erasmus student is obliged to prove his status by submitting of valid document (Learning Agreement or Traineeship Agreement).
- Student is obliged to pay accommodation service in accordance with Regulation of house rules and disciplinary responsibility of residents in the accommodation facilities of the Student centre Rijeka
- Unlimited use of self service washing and dryer machines (washing and drying of personal clothes) in laundry room is included in the listed prices.

Students can see other prices in the price list on our web page.

After move in / on beginning of the current month student receives a bill for accommodation on their e – mail address. Invoices can be paid:

- with a debit card at the reception from Monday to Friday from o8:00am to 02:00pm;
- through internet banking;
- in post office;
- in bank.

Accommodation users are obliged to pay their accommodation invoices until the date indicated on the invoice.

Payment can be done with card on reception, through internet banking, in bank or in post office.

9. Check - out

Erasmus student is obliged to announce check out from accommodation facility till 25^{th} day of the previous month.
